***AKC definition – “Limited Registration” means that the dog is registered, but no litter produced by the dog is eligible for registration. Dog with Limited Registration may not be entered in breed competition at Dog Shows but may compete in all other AKC events. The litter owner may later apply to change this designation and have the dog given full registration privileges but a fee and special application are required for this change.

The puppy has been vaccinated for distemper-hepatitis, the dates of such vaccination to be supplied to the Buyer at the time of the sale.

2 YEAR GENETIC GUARANTEE: In the event that your dog is diagnosed with a genetic disease of the hips that is **severe** in its nature, we will refund you the original purchase price, or replace your puppy. To make a claim under this you must submit your film(s) to OFA for a result of Severe. The dog must not have been bred for this contract to be valid. A replacement puppy can take 6-8 months.

72 HOUR GUARANTEE: Please have a DVM appointment scheduled. If for any reason the puppy is found to be a poor health risk you may return your puppy for a full refund. Please provide a statement from your DVM explaining the diagnosis. **WE CAN NOT PAY VETERNARIAN CHARGES.**

OFA certification is not a guarantee against orthopedic problems; it is your responsibility to provide proper diet and exercise appropriate for your dog's condition and age. Initial _____

All dogs come with limited registration. An “OPEN REGISTRATION CONTRACT” is to be submitted if you intend to show or breed.

Puppy purchased will be named with the Maple Creek Prefix.

The new owner is required to take the puppy to the vet of their choice within 48 hours of purchase. (Verification of this must be faxed to the breeder within 48 hours after the appointment)

The puppy **MUST** be Micro Chipped at or before six months of age (*)

The puppy **MUST** be spayed or neutered at six months of age.

In the event you can no longer keep your dog we should be notified, the dog always has a home back at Maple Creek Labs.

Accidents and other illness are not included in this guarantee. It is your responsibility to provide adequate fencing or runs, and properly vaccinate and care for your puppy.

The guarantees and refunds described above are your sole and exclusive remedy in the event of any problems with the puppy.

Any and all rights and claims for damages of any sort, including consequential, punitive, and emotional distress damages are waived.

*This contract is issued to the original buyer.

*Due to an increase in returned checks due to insufficient funds final payment must be in cash or bank check drawn from a bank with branches in New Hampshire.

*If you cannot be here to select a puppy at appropriate time, we will pick out a puppy for you.

No other conditions, guarantees, or obligations' concerning the sale of this puppy applies. The agreement may be modified or amended only in writing and signed by all the parties.
